Dear Customer,

On 10/28/08 ECHA, European Chemicals Agency, published the first official SVHC list - Substances of Very High Concern. The latest update to this list was on January 16, 2020 when 4 more substances were added to the list bringing the total to 205. The full list is available on the ECHA website - look for Authorization Candidate List, SVHCs.

Four of these 205 substances are in some products, in the uncured state, made by Taiyo America, Inc. During the cure reaction it is expected that these substances react and lose their identity.

The four SVHC substances and the wet/uncured products which contain them are listed below.

1,3,5-tris(oxiranylmethyl)-1,3,5-triazine-2,4,6-(1H,3H,5H)-trione (TGIC)
